# Safety Spotlight: Member Interview Mindy Prichard, BS in Safety Management, ASP



# The May Spotlight is Mindy Prichard, Safety & Health Inspector, KDOL

Where did you go to school? I went to Central Missouri State University in Warrensburg, MO and have a Bachelor of Science in Safety Management.

How long have you been in the safety industry? 29 years and still love it as much as I did the first year.

How long have you been in your current position? 2 years (2019 to current), but 5 former years (1992-1997).

What is your current position and from a safety standpoint what are your primary responsibilities? I am a Safety & Health Inspector for OSHA 21(d) OSHA Consultation Program in the State of Kansas-Department of Labor, Division of Industrial Safety & Health. We receive requests from small employers (<500) to assist them with OSHA compliance for free, and without fines or penalties. I provide assistance in the northeast corner of the state, but most employer requests are in Johnson & Wyandotte County. I perform physical hazard assessments, program reviews, records reviews, and training as requested.

What made you decide to go into safety? Two things happened. First, my mom was holding the CMSU course catalog (because nothing was online then) at home and she said that I should look into the safety degrees they offered because it had my name all over it. (I dismissed her instantly because I was 18 and knew more than her and said I would major in Biology). LOL! Second thing, I was typing my boyfriend's "safety" papers for him because they didn't have computers then and not everyone had a typewriter and I did and he didn't type well. Typing his papers gave me an "ah-hah" moment as I read what I was typing and I became interested in safety. I took one class in the Gen Ed curriculum and was sold on it! Moral of the story: moms know.

What are some of your memorable experiences or accomplishments related to your time in the safety field? There has never, ever been a dull moment in my career and that is what I love the most about this job. I am convinced after 29 years in safety that over 98% of accidents are the result of human error, including my own accidents (not at work...thank God). I have inspected prisons, a slaughter house, mop makers, grain handlers, machine shops, foundries, railroad, COVID-19 labs, State buildings (including the Capitol where I went in the tunnels and dome), mining equipment manufacturer, etc. And every single place is memorable. My 22 years in manufacturing working for Hallmark Cards, Harley-Davidson, and Russell Stover Chocolates were also very rewarding experiences and I cherish the memories and lessons learned in safety from working there.

What are some of your hobbies or favorite activities? Walking the dogs, riding bikes, eating ice cream, taking naps, watching my 1-yr old granddaughter, going to church, jigsaw puzzles, and going on vacation with my husband.

What does your ASSP Membership do for you? ASSE/ASSP has provided me with 29 years of networking, volunteering opportunities, education, training, field trips, lunches, and friendships in the field of safety. As most of you know, when you are working for an employer, you are typically the only safety person on staff and it is hard to connect with someone not in your field that doesn't share your passion for safety. ASSP provided that connection. I am so proud to be a part of our ASSP HOA Chapter and glad they have been a part of my 29 year journey.

## **Tornado Preparedness and Response**

Tornadoes can occur with little or no warning. Taking precautions in advance of the storms, such as developing an emergency plan, learning the warning signs, and monitoring tornado watches and warnings, can help you stay safe if a tornado occurs in your area.

OSHA and NOAA are working together on a public education effort aimed at improving the way people prepare for and respond to severe weather. This page is designed to help businesses and their workers prepare for tornadoes, and to provide information about hazards that workers may face in the aftermath of a tornado.

To prepare for a tornado, businesses should develop an emergency plan. The plan should include details on suitable places to take shelter, policies to ensure all personnel are accounted for, and procedures for addressing any hazardous materials that are on-site. It is also recommended that individuals develop action plans for their families.

After a tornado has occurred, as businesses take steps to recover from the storm, workers may face significant hazards including the potential for additional storms, downed electric lines, and sharp debris. Workers should also be aware of hazards from heat stress and from equipment used during response/recovery operations, such as portable generators. Workers will need to take special precautions in order to stay safe during response and recovery operations. The Response/Recovery page has more information on these hazards and protections workers should employ.

#### **Employer Responsibilities**

Each employer is responsible for the safety and health of its workers and for providing a safe and healthful workplace. Employers are required to protect workers from the anticipated hazards associated with the response and recovery operations that workers are likely to be involved with.
